This LCA was evaluated according to EN15804+A2. It was concluded that the LCA complies with this standard.

Fiber Basalt Clima, a three-layer polypropylene pipe of the new generation, which is reinforced with basalt fiber, is the ideal choice for air conditioning or cooling distribution. Compared to standard PPR pipes, it has up to 3 times lower thermal longitudinal expansion, which is especially beneficial when used on long routes, where temperature-longitudinal changes of the material would cause major problems.
