Wavin offers inspection wells with riser pipes in sizes 315 and 425 mm, which are designed in accordance with the European standard EN 13598-2 regarding deep installations and groundwater pressure. They are typically used as separation wells, where each individual home is connected to the public sewer system, and on private land.

This LCA was evaluated according to EN15804+A2. It was concluded that the LCA complies with this standard.
