The Stabi Plus pipe is the ideal choice for internal installations of pressure distribution for drinking water, hot water and central heating. It is a three-layer tube with aluminum foil, which provides the necessary oxygen barrier. This prevents the penetration of oxygen into the heating water, which increases operational safety. In addition, the Stabi Plus pipe is highly resistant to mechanical damage.

This LCA was evaluated according to EN15804+A2. It was concluded that the LCA complies with this standard.
