Drainage made of double-walled Wavin X-Stream pipes and fittings are high-strength SN8 products in the diameter range DN/ID 100 – 800 mm. Efficient drainage is ensured by 1.5 mm wide longitudinal slots, and their area is not less than 50 cm²/m of pipe. Thanks to the availability of pipes in three types of perforation (TP, LP and MP), the drainage system can be easily adapted to the investment conditions.

This LCA was evaluated according to EN15804+A2. It was concluded that the LCA complies with this standard
